

PVC SCHEDULE 40 IPS SOLVENT WELD PRESSURE FITTINGS

LETTER OF COMPLIANCE

Scope:

This letter of compliance covers the requirements for ½" through 24" (12 mm – 600 mm) PVC **Schedule 40** Solvent Weld Pressure Fittings made to Iron Pipe Sizes (IPS). These products meet or exceed performance standards set by the American National Standards Institute (ANSI), the American Society of Testing and Materials (ASTM), CSA International (CSA), and NSF International (NSF).

Material:

Rigid PVC Poly(Vinyl Chloride) used in the manufacturing of **Schedule 40** Solvent Weld Pressure Fittings complies with the material requirements of ASTM D1784, *Standard Specification for Rigid Poly(Vinyl Chloride) (PVC) Compounds and Chlorinated Poly(Vinyl Chloride) (CPVC) Compounds*. The compound has a cell classification of 12454. The compound is listed with NSF for potable water service.
